

CPO Rangatahi- General Practice

Purpose:

To improve access to Primary Care Services for Rangatahi by reducing cost as a barrier

Service

This pathway will fund the co-payment component for General Practice and Urgent Care consultations provided by a General Practitioner, Nurse Practitioner, or Practice Nurse.

Eligibility Criteria:

To be eligible to receive funded services through this pathway Rangatahi must:

- 1. Reside in the Te Whatu Ora Health New Zealand Te Matau a Māui, Hawke's Bay (Te Whatu Ora Hawke's Bay) catchment area
- 2. Age 14-24 years of age
- 3. Require access to a routine consultation with a General Practitioner, Nurse Practitioner, or Registered Nurse within a General Practice or Urgent Care setting

Exclusions

- 1. Age 25 years and over
- 2. Rangatahi residing outside of the Te Whatu Ora- Hawke's Bay catchment area
- 3. Services that have alternative funding mechanisms, e.g. Combined Primary Options (CPO), Sexual Health and Integrated Primary Mental Health
- 4. Extended consultations or specialised services including minor surgery or cosmetic surgeries
- 5. Home visits

No Charge to Patient

- No co-payment for consultation
- No GMS can be claimed

Prescription Co-payment for Community Pharmacy

This pathway includes access to zero fee medications for all funded prescription items from participating pharmacy.

General Practice Referral Pathway

- Rangatahi presenting to general practice, urgent care who meet the eligibility criteria, will be offered a General Practitioner, Registered Nurse and/or Nurse Practitioner service as clinically appropriate
- 2. Services funded under this pathway are for a standard consultation only, either face to face or virtual
- 3. Patients are responsible for payment of any services delivered outside of this pathway ie: minor procedures, dressings
- 4. Rangatahi to be provided with appropriate health interventions, screening and health promotion messages.
- 5. Rangatahi can be referred to social and other health services, such as HIP's and Health Coaches, as appropriate
